

Kindly clarify to me the following as regards the logo competition for KMRC <ul style="list-style-type: none"> - Can one submit as an individual and whether the confidential business questionnaire Part I must be filled and stamped if one is an individual and does not have a business name or company? - Is one required to do a write-up of the affirmation of the submission as one's own work and consent for indemnifying KMRC from losses and submit this together with the logo designed? 	As stated in the tender document, you MUST AFFIRM that the submission is your own work and has not been borrowed, plagiarized repeated etc. and indemnify KMRC accordingly
