DRAFT NATIONAL POLICY ON VIRTUAL ASSETS AND VIRTUAL ASSET SERVICE PROVIDERS; AND VIRTUAL ASSETS SERVICE PROVIDERS BILL, 2024

The National Treasury and Economic Planning through a Multi-Agency Task Force has developed a draft National Policy on Virtual Assets (VAs) and Virtual Assets Service Providers (VASPs); and the Virtual Assets Service Providers Bill, 2024. The Policy and the Bill provide a framework for oversight and development of the Virtual Assets ecosystem. The documents are available on the National Treasury website (www.treasury.go.ke).
